- 4) Leave Rules of regular Government employees will not be applicable in this respect.
- 5) Consolidated monthly remuneration will be Rs. 21,000/-.
- 6) Engagement shall be terminated on unsatisfactory performance and / or involvement in any unlawful activity with one month's notice upon the incumbent.
